All Drivers must sign below to acknowledge your understanding and agreement to the following requirements for the 2010 Point Fund and Weekly Payout:

- *Drivers must finish 80% of the race events to be eligible for the point fund money*
- *Each Driver, will receive one flex plan book valued at \$50 that can be taken out of your purse the first event or you can pay in advance.*
- *Drivers/Crew Members of ANY Division must purchase a NASCAR or INEX license (As directed by LES ex: Late Model Crew and Driver MUST purchase a NASCAR License)*
- *Drivers must attend the 2010 Awards Banquet*
- *Drivers must do a minimum of two legitimate driver and car appearances to be eligible to receive the point fund money. (Driver and car must be present at appearance to count the appearance)*
- *Drivers must run all contingency decals (INEX, NASCAR and LES Division Sponsors) as directed by LES, NASCAR, and INEX.*
- *If a Driver does not run all contingency decals they will not receive weekly points or purse money. No Exceptions.*
- *Late Model competitors must purchase a minimum of 5 gallons of fuel each race night.*

2010 LAKE ERIE SPEEDWAY MEMBERSHIP APPLICATION, AGREEMENT AND COMPETITION LICENSE

IN CONSIDERATION of the acceptance by Lake Erie Promotions, Inc., t/d/b/a the Lake Erie Speedway (hereinafter collectively LES), of this application and agreement, the payment of the required fee, the issuance of a LES/NASCAR License, my being permitted on the speedway or raceway premises of any Lake Erie Speedway event, or any of the foregoing, I, for myself, my heirs, next of kin, personal representatives and assigns, hereby agree (in accordance with Pennsylvania law) as follows:

1. To comply with the Lake Erie Speedway Official Rules and Regulations (as amended);
2. To abide by the decisions of Lake Erie Speedway Officials;
3. To be bound by the procedures for and results of protests and appeals, which shall be the exclusive remedy for any aggrieved driver; waive any right to litigate any decision of the Lake Erie Speedway Officials or the results of any Lake Erie Speedway event;
5. To release, waive, discharge and covenant not to sue Lake Erie Speedway, Lake Erie Speedway Officials or and other Lake Erie Speedway drivers and each of them from all liability to the licensed or permitted driver, his personal representatives, assigns, heirs or next of kin for any and all loss or damage, and any claim or demands therefore on account of or resulting from injury to person or property or resulting in death of the licensed or permitted driver, whether caused in whole or in part by the negligence or any other wrongdoing of Lake Erie Speedway, Lake Erie Speedway Officials or any other Lake Erie Speedway driver while the licensed or permitted driver is in or upon the speedway grounds and/or competing, observing, or for any purpose participating in the event;
6. To indemnify, save and hold harmless Lake Erie Speedway, Lake Erie Speedway Officials and other Lake Erie Speedway drivers and each of them from any loss, liability, damage or cost they may incur due to the presence of the licensed or permitted driver in or upon the speedway grounds or in any way competing, observing or for any purpose participating in the event and whether caused in whole or in part by the negligence or any other wrongdoing of Lake Erie Speedway, Lake Erie Speedway Officials or Lake Erie Speedway drivers or otherwise;
7. To assume full responsibility for and risk of bodily injury, death or property damage due in whole or in part to the negligence or any other wrongdoing of Lake Erie Speedway, Lake Erie Speedway Officials and other Lake Erie Speedway drivers while in or upon the speedway grounds and/or while competing, observing or for any purpose participating in the event;
8. To reimburse the attorneys' fees, expert witness fees, court costs, and all other expenses incurred by Lake Erie Speedway and Lake Erie Speedway Officials in any litigation commenced by or on behalf of the licensed or permitted driver, his personal representatives, assigns or next of kin, regardless of the outcome of any such litigation.
9. To waive any right to jury trial; and
10. To the exclusive venue of the Court of Common Pleas of Erie County, Pennsylvania.

I HEREBY CERTIFY that any license or permit granted hereunder is granted for the sole purpose of enabling me to participate in the furtherance of an enterprise, a race, or other motorsports-related activity. My presence in, about, or en route into or out of any premises where Lake Erie Speedway sanctioned events are presented is in furtherance of that Lake Erie Speedway event.

BY MY SIGNATURE BELOW, I hereby release and assign to Lake Erie Speedway the right to use my name, my image, the image of my race car, and the names of my sponsors in press releases, announcements or advertisements for any Lake Erie Speedway sanctioned event, whether said press release, announcement or advertisement is in the print or electronic media, in still or motion pictures, drawings or other artistic renderings, relating to or depicting my participation in any Lake Erie Speedway sanctioned event.
